CIRCULAR

No. MGC/ A/ 3561 dt. 09.06.2020

Sub : Amendment to the Circular of Extension of lockdown and revised guidelines on the measures to be taken in respect of Easing of Restriction and phase-wise opening of lockdown.

Ref : MGC/A/3561 dated 02.06.2020

In continuation to the Circular No. MGC/ A/ 3561 dated 2nd June 2020, I, I.S. Chahal, IAS, Municipal Commissioner as per the amendments to the Guidelines for Easing of Restrictions and phase-wise opening of lockdown in respect of MISSION BEGIN AGAIN, hereby issue the following order to amend and include the following in the guidelines dated 2nd June 2020:

In Clause 6, under MISSION BEGIN AGAIN PHASE I in sub-clause (i) Outdoor physical activities, after point number 6) the following condition is added:

"7) No equipment / garden equipment / open air gym equipment / play area equipment like Swings / bars etc will be allowed to operate"

In Clause 6, under MISSION BEGIN AGAIN PHASE II sub-clause (i) shall stand amended and read as under:

"i) All markets, market areas & shops, except malls and market complexes, are allowed to function for the full working hours with following conditions."

All shops on the one side of the road / lane/ passage will open for full working hours on one day while all the shops of the other side of the road will remain open on the next day and so on. Market /Shop Owner's Associations shall involve themselves for giving effect to the above arrangements and for smooth enforcement of requirements of social distancing and traffic management.

In Clause 6, under MISSION BEGIN AGAIN PHASE II sub-clause (i)-b. shall stand amended and read as under:

"b) The shops will remain open for the full working hours from Monday to Saturday and closed on Sunday."

In Clause 6, under MISSION BEGIN AGAIN PHASE III, clause I. will read as under:

"I) All private offices can operate up to 10% strength or 10 people, whichever is more, with remaining persons working from home. However, all the employers will take sensitization program to educate the employees about adequate precautions on returning home so that vulnerable group especially the elderly is not infected. (with effect from 8th June, 2020)".

In Clause 6, under MISSION BEGIN AGAIN PHASE III, the following sub-clause is added after sub-clause I.:

"II) Printing and Distribution of newspapers (including home delivery) is allowed. It shall be with the knowledge of the receiver and for the delivery of newspaper, personnel shall wear mask and use hand sanitizer and maintain social distancing. (with effect from 7th June 2020)"

In Clause 7, the subtitle " the following activities will remain prohibited across the City of Mumbai Limits" be read as sub-clause (a) and the following sub-clause is added sub-clause (b) :

*"b) Relaxation for office / staff of Educational Institutions :
The offices/staff of Educational institutions (Universities / Colleges/ Schools) can operate only for the purpose of non-teaching purposes including development of e-content, evaluation of answer sheets and declaration of results"*

In Clause 8, after sub-clause i. the following sub-clause shall be added:

"ii) However, interstate and inter district movement of persons shall continue to be regulated. However the inter-district movement of persons within the area of Municipal Corporation under the MMR (Mumbai Metropolitan Region) shall be allowed without any restrictions. The movement of standard labor, migrant workers, pilgrims, tourist, etc. will continue to be regulated as per SOPs issued."
