Reference is requested to Urban Development Department (Govt. of Maharashtra)'s notification under No.TPS-1813/3067/CR-122/MCORP/12/UD-13 dtd. 16-11-2016 regarding modification to Regulation No.34 of D.C.Regulation 1991, in respect of "Transferable Development Rights."

As per provision of Paragraph No.5.4.1 of the said Notification, Utilisation of Transferable Development Rights (TDR) on receiving Plot is as prescribed below:

The proposals for utilisation of TDR are being processed as per the above table by Zonal Building Proposal Offices/D.P. Deptt. However, in certain cases, for allowing utilisation of TDR in various Town Planning Schemes, the road width is not mentioned in the Sanctioned Development Plan as roads situated in these Schemes are Town Planning Roads. The details of such schemes alongwith Provisions of Town Planning Development Plan are as under:-

Planning Scheme roads is mentioned as either 40'; or 12.192 Mt. (40'), or 12.19 Mt. (40'), in various Town Planning Schemes. Besides, the road width of these Town Planning Scheme roads is not reflected in Sanctioned Revised Development Plan 1991 & Revised Draft Development Plan published in 27th May 2016. It may also be mentioned here that in case of proposed D.P. roads (i.e. roads situated outside T.P.Schemes), the road width is mentioned as 12.20 mtrs. in the S.R.D.P. 1991 & R.D.D.P. May 2016, as can be seen from the plans.

Thus, in order to avoid ambiguity; a uniform policy needs to be adopted to decide about the utilisation of Transfer of Development Rights (TDR) & Road width relations for Plots situated within the Town Planning Schemes and for the Plots situated outside Town Planning Schemes. As such; width of roads situated in Town Planning Schemes where road width is shown as 40'; 12.192 Mt. (40'), 12.19 Mt. (40') will be considered at par with the road width of proposed D.P. roads mentioned in Sanctioned Development Plans (i.e. 12.20 Mtrs.) for the purpose of processing the utilization of T.D.R. in T.P.Schemes & Zonal B.P. Office/D.P. Depth. will be instructed to process utilisation proposals of Town Planning Scheme Plots accordingly. After U.D.D. will be sufficiently accordingly.
