The tenure of the Committee shall be for two years and it will be reconstituted thereafter as per requirement


Terms of Reference:-

1. The Committee shall be of advisory nature and it will advise Municipal Commissioner on the following matters:-
 - a. Various D.P. provisions and D.C.Regulations and interpretations thereof.
 - b. Interpretations of policy circulars issued in the past and also clarifications received from the State Government.
 - c. Specific cases referred to the Committee by the M.C. in respect of application of D.P. provisions, D.C. Regulations, circulars and Govt. clarifications to such specific cases.
 - d. Any D.P./B.P. matters referred to the Committee by the M C.

- e. Procedures to be adopted in D.P./B.P. Sections to streamline working with a view to expedite disposal of cases, whenever necessary.
2. In specific cases, if the Chairman desires any Expert from the other fields may be invited for the meeting of the Committee.
 3. It will be open for the Municipal Commissioner to overrule the recommendations of the Committee, after giving justification for the same.

The office of Chief Engineer (D.P.) shall render necessary help for the function of the Committee i.e. provision of place for the meetings, secretarial assistance, etc.
