Sub: Ministry of Environment and Forest, New Delhi letter dated 25<sup>th</sup> Jan, 2011.

The Ministry of Environment & Forest, New Delhi vide letter dated 25<sup>th</sup> Jan, 2011 issued directions under section 5 of Environment (Protection) Act, 1986 regarding identifying the violations under CRZ Notification, 1991. The Para 7 of the said letter mentions that gazetting of the Notification of 2011 does not condone any violations of the CRZ Notification, 1991, unless otherwise and explicitly provided in these two Notifications. Copy of the said letter of MoEF is enclosed herewith.

MCZMA has issued clarification letters informing the CRZ status of plot in Bay cases about whether plot is in CRZ or Non CRZ as per provisions of CRZ Notification, 2011. List of such cases is enclosed herewith. This is to inform you that these clarification letters does not condone any violations of the CRZ Notification, 1991, as specified in Para 7 as mentioned above. If the violation of CRZ Notification, 1991 is observed, then only such matters be referred to Environment Department/MCZMA for examination.
