CIRCULAR

Ref:MGC/F/9272 dated 31.05.2019

MoEF&CC vide its letter u/no.F.No.19-74/2016-IA.III dtd.11.05.2017 has granted CRZ clearance to the Coastal Road (South) from Princess Street Flyover to Worli End of Sea Link in Mumbai i.e. Mumbai Coastal Road Project (South). MoEF&CC stipulated Specific Condition (vi) that it shall be ensured by MCGM that the open spaces created by reclamation as well as ancillary facilities related to road maintenance are fully protected against encroachment, illegal parking, public events/processions of any kind, hawkers, religious structures, street vendors or any illegal occupants etc. Violation of this will amount to breach of clearance. 10:500

The project work envisages construction of Coastal Road with reclamation of around 90 Ha out of which around 20 Ha areas would be for road carriageway & remaining area around 70 Ha will consist of open green space. The reclaimed open area is proposed to be used as garden , open green space , cycle track , jogging track , Butter fly garden , Amusement park , Promenade , Road median as open green space , BRTS Bus depot etc. without permitting other development on landward side of such roads till existing High Tide Line of Coastal Road (South) as per above provision.

In view of that, it is hereby directed to all the concerned Authorities responsible for approval of development permission to take note of the above provisions & take necessary actions accordingly. In no case, this open space shall be used for any development /residential/commercial purpose violating the conditions as stipulated in MoEF&CC's CRZ Clearance dated 11.05.2017.

This shall be scrupulously followed since it is deemed to be considered as undertaking given by Municipal Corporation of Greater Mumbai to Ministry of Environment Forest & Climatic Change, Government of India.
