Reference is requested to the letter received from P.E.A.T.A. addressed to Hon'ble Municipal Commissioner, Ch.Engr.(D.P.) & Director (E.S.&P.) and remarks thereon as "PI. put up clarification on X' for Hon'ble M.C.'s perusal and approval of Hon'ble M.C.

The above referred circulars depict the guidelines to be followed while granting the facility of installments in payment of fees / premiums / charges / deposits. Clause 8(b) of above referred circular dated 17.09.2019 states that "C.C. equivalent to 10% of approved Built-up Area shall be restricted, if BUA of topmost floor is more than the 10% BUA, then the C.C. for the entire top most floor shall be restricted."

It was brought to the notice by P.E.A.T.A. that in Zonal Building Proposal Offices in some of the wards, C.C. equivalent to 10% of total BUA approved (including the BUA for which installment facility is availed)

In order to avoid ambiguity and to bring more clarity, further?" clarification as regards to Clause 8(b) of Circular dated 17.09.2019 is as

C.C. equivalent to 10% of approved Built up Area shall be 8(b)(i):restricted for the area for which installment facility is availed. If earlier the plans are approved and full payments against the approved area are made then such area shall not beconsidered while restricting the C.C. The additional BUA as per amended plans shall only be considered.

## CIRCULAR

Sub: Facility of installments in Payments for grant of IOD/CC for various fees / charges / deposits / premiums to be paid in respect of Building Permissions.

Considering the request received from various Stakeholders in Housing Industry, the above referred circulars were issued for the guidelines to be followed to grant the facility of installment in payment of fees / premiums / charges / deposits.

In order to avoid ambiguity and to bring more clarify, further clarification as regards to Clause 8(b) of Circular dated 17.09.2019 is as under.:-

- 8(b)(i):- C.C. equivalent to 10% of approved Built up Area shall be restricted for the area for which installment facility is availed. If earlier the plans are approved and full payments are made then such area shall not be considered while restricting the C.C. The additional BUA as per amended plans shall only be considered.
- 8(b)(ii):- For plans approved earlier and full payment is not done for the BUA approved earlier then C.C. equivalent to 10% of the total BUA (for which payment is not done) shall be restricted.
- 8(b)(iii): For the above cases, if BUA of topmost floor is more than 10% BUA, then C.C. for the entire topmost floor shall be restricted. If BUA of topmost floor is less than 10% then C.C. for entire topmost floor plus the area of bottom floor / floors total aggregating to 10% shall be restricted.
