Sir,

It has come to the notice of AAI CHQ that applicants in Mumbai are finding it difficult to furnish certificates of coordinates and elevation of their sites, as required by AAI for issuing NOC for height clearances.

As per existing guidelines issued by AAI, it is mandatory for the applicants to provide surveyed elevation and WGS-84 coordinates of the site from a qualified professional or an agency authorized for the purpose by the concerned Department/Unit/Local Bodies of the Government.


MCGM vide letter dated 7th September, 2015 has intimated that they do not have a list of authorized Surveyors for issuing WGS-84 coordinates and site elevation certificates. However, MCGM have a list of registered licensed Surveyors, having academic qualification in Diploma/Degrees and Master Degree in Civil Engineering Branch, who are dealing with the licentiate work related to Building Proposal Department.

In order to ease hardships faced by applicants, the appropriate authority has decided to permit the applicants to obtain the site coordinates and site elevation certificates from any of the licensed Surveyors. The applicant is required to countersign these certificates and submit them to AAI along with the Undertaking that he/she is responsible for the correctness of site coordinates and site elevation. If at any stage it is found otherwise, he/she is also liable to penal action.

This issues with the approval of the Competent Authority.
