

CIRCULAR

Sub : Creating independent unit of Fire Department at ward level.

In order to ensure the compliances of Fire Permissions, Fire N.O.Cs. issued by Fire Department and compliance of provisions of Maharashtra Fire Prevention & Life Safety Measures Act, a dedicated unit is created at ward level. This unit will consist of one Fire Officer designated by C.F.O. and one Fireman. If there is shortage of staff, C.F.O. can nominate one Officer / Fireman for two wards so as to avoid any hindrance to operational work of fire fighting. This unit will be entirely under administrative control of concerned Asstt. Commissioner. However, functional/technical control will be with C.F.O. C.F.O. will provide one Officer / Fireman for each unit and concerned Asstt. Commissioner of ward will provide Executive Assistant, office premise, furniture, legal support for prosecution, etc. so as to create a separate section on the lines of other sections in ward like, B&F, MOH, SI(Licence), etc. The incharge of Fire Unit at ward level will exercise all powers delegated to him for compliance of Fire Safety Measures. If certain powers are not vested with him, he will take approval of higher Officer of the Fire Department with whom these powers are vested. C.F.O. will ensure that while giving importance to fire prevention and compliance, the operational work of fire fighting should not suffer.
