

Whereas, the Government in the Urban Development, Public Health and Housing Department vide Notification No. BKR1173/51924/WII dated the 18<sup>th</sup> July, 1973 has notified the area of Bandra-Kurla Complex in the schedule attached thereto and subsequently under the Government Notification No. BKR 1177/262/UD-5, dated the 7<sup>th</sup> March, 1977, in supersession of Government Notification dated the 18<sup>th</sup> July, 1973, referred to above, the Government has appointed the Bombay Metropolitan Region Development Authority to be the Special Planning Authority (hereinafter referred to as "the said Authority") under sub-section (1) of section 40 of Maharashtra Regional and Town Planning Act, 1966 (hereinafter referred to as "the said Act") for the area mentioned in the schedule of Government Notification dated the 7<sup>th</sup> March, 1977;

And whereas, the Government of Maharashtra has under sub-section (1) of section 115 as substituted by section 40(3) of the said Act sanctioned the Planning Proposals including Development Control Regulations submitted by the said Authority in respect of Bandra-Kurla Complex under Government in the Urban Development and Public Health Department Notification No. BKR 1177/262/UD-5, dated 9<sup>th</sup> April, 1979

And whereas, as per provision of Regulation No.4 (ii) of General Development Control Regulations for Bandra-Kurla Complex, the F.S,I, upto 3.00 is available for Residential use in 'G' Block.

And whereas, the said Authority vide its Resolution No. 1282 dt. 6/3/2012, has decided to intiate modification to Regulation No. 4(ii)(hereinafter referred to as "the said Regulation")to increase F.S.I. 3.00 to 4.00 for residential use in 'G' Block and empowered Metropolitan Commissioner to take further action under section 37(1) of the said Act.

And whereas, the said Authority vide letter dated 18<sup>th</sup> January 2013 has submitted the modification proposal to the said Regulation to the State Government for final sanction after follwing the procedure as contemplated under section 37(1) of the said Act. (hereinafter referred to as "the said Modification")

And whereas, after consulting the Director of Town Planning, Maharashtra State Pune, Government is of the opinion that the said modifications shall be sanctioned; Now, therefore, in exercise of the powers conferred under section 37(2) of the said Act, the Government hereby –

- A) sanctions the said modification to the said Regulation, specifically described in the Schedule mentioned below ;
- B) Fixes the date of publication of this Notification in the Government Gazette as the date of coming into force of this modification;



directs the said Authority that, in the Schedule of Modification sanctioning the said Regulations, after the last entry, the schedule referred to as (A) above shall be added.
