Preface:-

Considering the importance of efficient Municipal Solid Waste Management, the Hon'ble National Green Tribunal (NGT), on 22nd December 2016, had issued an order (O.A. No. 199 of 2014) with directions to all the states/UTs for effective implementation of the SWM rules, 2016. A video conference was conducted with all the states in the month of August 2018 and vide NGT O.A. No: 606 of 2018, Hon'ble Tribunal has further given directives for effective implementation of the SWM rules, including constitution of a State Level Monitoring Committee for every state.

Government Resolution:-

State Level Committee for effective implementation of SWM Rules for State of Maharashtra is hereby being constituted:

- i. Chairperson: Secretary, Urban Development Department.
- ii. Member: Secretary, Environment Department.
- iii. Member: Representatives from CPCB, and MPCB.

The role of State Level Committee will be as follows:

- a. To interact with Local Bodies twice in a month.
 - b. To administer technical and policy issues in accordance with SWM rules 2016 and instructions issued by Apex and Regional Committees.
 - c. To Submit of reports of working to Regional Committees **on a monthly basis.**
 - d. To monitor formation of ULB level Committees for effective implementation of SWM 2016 in bigger ULBs.
 - e. To Encourage Public involvement in compliance of Solid Waste Management Rule, 2016.
 - f. To Encourage information regarding SWM status being put up in public domain.
Etc.
2. The State Level Committee may have interactions with Local Bodies once in two weeks.
 3. The representatives from the Centre Pollution Control Board and State Pollution Control Boards would assist the State Level Committee.
 4. In accordance with the order of the NGT, State Level Committee should resume their work at the earliest.

5. In accordance with the orders from the NGT the tenure of the committee will be for a period of one-year subject to any further orders.
