No. TPB-4317/629/CR-118/2017/EP/UD-11.—Whereas, in accordance with the provisions of sub-section (1) of section 31 of the Maharashtra Regional and Town Planning Act, 1966 (hereinafter referred to as "the said Act"), the State Government *vide* Notification No. TPB-4317/629/CR-118/2017/DP/UD-11, dated 8th May 2018 (hereinafter referred to as "the said Notification") has accorded sanction to the Draft Development Plan of Greater Mumbai with modification shown in SCHEDULE-A appended to the said Notification excluding the substantial Modification as shown in SCHEDULE-B appended to the said Notification ;

And whereas, in accordance with the provisions of sub-section (1) of section 31 of the said Act, the State Government *vide* Notice No. 4317/629/CR-118/2017/EP/UD-11, dated 8th May 2018 (hereinafter referred to as " the said Notice ") have invited suggestions and objections from any person in respect of the proposed Modifications of Substantial Nature (EP), as specified in SCHEDULE-B appended thereto to the said Notice ;
