(१) वसुली अधिकारी यांनी महाराष्ट्र सहकारी संस्था अधिनियम १९६० चे कलम १५६ व नियम १९६१ चे नियम १०७ मधील तरतुदीनुसार कर्जवसुलीची कार्यवाही करावी. कर्ज वसुली करतांना सहकार कायदा नियम यातील तरतुदी व परीपत्रकीय सूचनांचे पालन न केल्याचे निर्दर्शनास आल्यास आवश्यक ती चौकशी करून आवश्यकता भासल्यास सदरचे अधिकार तात्काळ काढून घेण्यात येतील.

(२) सदरचे अधिकार सहकार कायदा कलम १०१ व ९१ अन्वये प्राप्त वसुली दाखल्याची अंमलबजावणी करण्याकरिता असतील.

(३) वसुली अधिकारी यांनी दरमहा सोबत जोडलेल्या विहित नमुन्यात अ-३,अ-४, व ब कर्ज वसुलीची माहिती संबंधित जिल्हा उपनिबंधक, सहकारी संस्था यांचे कार्यालयास सादर करावी. ज्या सहकारी संस्थेचे कार्यक्षेत्र विभाग, दोन विभाग अथवा राज्य कार्यक्षेत्र आहे त्या संस्थांनी देखील त्यांचे मुख्य कार्यालय ज्या जिल्ह्यामध्ये आहे त्या जिल्हा उपनिबंधक यांचे कार्यालयास माहिती सादर करावी.

(६) मा. उच्च न्यायालय, मुंबई यांनी रिट याचिका क्रमांक १९४२/२०१३ दि बेसिन कॅथोलिक को-ऑप. बँक विरुद्ध महाराष्ट्र राज्य व इतर या याचिकेमध्ये दिनांक ५ डिसेंबर २०१५ रोजी दिलेल्या आदेश विचारात घेवून वसुलीची कार्यवाही करताना महाराष्ट्र सहकारी संस्था अधिनियम १९६० व नियम १९६१ अन्वये प्राप्त असलेल्या अधिकारानुसारच वसुलीची कार्यवाही करावी.

(७) वसुली अधिकारी यांनी नमूद केलेल्या कालावधीत वसुलीचे कामकाज समाधानकारक केले नसल्याचे निर्दर्शनास आल्यास किंवा प्रदान केलेल्या अधिकाराचा गैरवापर करीत असल्याचे निर्दर्शनास आल्यास, प्रदान केलेले अधिकार काढून घेतले जातील व भविष्यात असे कोणतेही अधिकार अशा व्यक्तीस प्रदान करण्यात येणार नाही.

(१२) वसुली अधिकाऱ्यास, थकबाकीदाराकडून वसुली दाखल्यानुसार वसुलपात्र रक्कम व सरचार्ज रक्कम याशिवाय इतर कोणतीही रक्कम वसुल करता येणार नाही.

क्रमांक टीपीबी ४३१३/६३०/प्र. क्र. १०७/२०१३/नवि-११.— ज्याअर्थी, बृहन्मुंबई क्षेत्राची विकास नियंत्रण नियमावली (यापुढे ज्यांचा उल्लेख “उक्त विनियम” असा करण्यात आला आहे.), शासन नगरविकास विभागाकडील अधिसूचना क्र. डिसीआर/१०९०/आरडीपी/नवि-११, दिनांक २० फेब्रुवारी १९९१ अन्वये महाराष्ट्र प्रादेशिक व नगररचना अधिनियम, १९६६ (यापुढे ज्याचा उल्लेख “उक्त अधिनियम” असा करण्यात आला आहे.) च्या कलम ३१(१) खालील तरतुदीनुसार मंजूर झालेली असून दिनांक २५ मार्च १९९१ पासून अंमलात आलेली आहे ;

आणि ज्याअर्थी, उक्त विनियमातील विनियम ५६(३) (सी) व ५७(४)(सी) मध्ये औद्योगिक वापर विभाग हा रहिवास/वाणिज्य वापर विभागामध्ये रुपांतरित करणेची तरतूद आहे ;

आणि ज्याअर्थी, महानगरपालिका आयुक्त, बृहन्मुंबई महानगरपालिका यांनी मा. मुंबई उच्च न्यायालयामधील रिट याचिका क्र. ६५१/२०१३ मधील दिनांक १३ मार्च २०१४ चे आदेश व सदर आदेशाच्या धर्तीवर मा. उच्च न्यायालयामध्ये दाखल झालेल्या याचिका विचारात घेऊन, औद्योगिक वापर ते रहिवास/वाणिज्य वापर रुपांतरणाचे बाबतीत सुविधा क्षेत्राच्या संदर्भात विनियम ५६(३) (सी) व ५७(४)(सी) मध्ये फेरबदलाच्या अनुषंगाने उचित आदेश देणेची विनंती केलेली आहे ;

आणि ज्याअर्थी, राज्य शासनाने राज्यातील महानगरपालिकांच्या विकास नियंत्रण नियमावलीमध्ये औद्योगिक वापर ते रहिवास/वाणिज्य वापर रुपांतरणाचे संदर्भात सुधारणा प्रस्तावित केलेल्या असून, त्यामध्ये औद्योगिक वापर विभागामध्ये रहिवास/वाणिज्य वापर अधिमूल्याचा भरणा करून अनुज्ञेय करणेसंदर्भात तसेच इतरही काही सुधारणा सुचविलेल्या आहेत ;

आणि ज्याअर्थी, उक्त विनियमातील विनियम ५६(३) (सी) व ५७(४)(सी) मधील विद्यमान तरतुदी सुधारित कराव्यात असे राज्य शासनाचे मत झालेले आहे ;

आणि ज्याअर्थी, उक्त विनियमातील विनियम ५६(३) (सी) व ५७(४)(सी) मध्ये या सोबतच्या परिशिष्टामध्ये नमुद असलेप्रमाणे फेरबदल (यापुढे याचा उल्लेख “प्रस्तावित फेरबदल” असा केलेला आहे) सार्वजनिक हितास्तव तातडीने करणे आवश्यक झालेले आहे ;

आणि त्याअर्थी, उपरोक्त परिस्थिती आणि वस्तुस्थिती विचारात घेता आणि उक्त अधिनियमाच्या कलम ३७ च्या पोट-कलम (१कक) अन्वये प्राप्त अधिकार आणि त्यासंदर्भातील सर्व शक्तींचा वापर करून, शासन याद्वारे प्रस्तावित फेरबदलाविषयी उक्त अधिनियमाच्या कलम ३७, पोट- कलम (१कक) चे खंड(क) नुसार कोणत्याही व्यक्तीकडून सदरची सूचना शासन राजपत्रामध्ये प्रसिद्ध झालेल्या दिनांकापासून एक महिन्याचे मुदतीमध्ये सूचना/हरकती मागविण्यासाठी, सूचना प्रसिद्ध करीत आहे ;

शासनाकडून असेही कळविणेत येत आहे की, प्रस्तावित फेरबदलाविषयी कोणत्याही हरकत/सूचना शासन राजपत्रात सदर सूचना प्रसिद्ध झाल्याच्या दिनांकापासून एक महिन्याच्या आत उप संचालक, नगररचना, बृहन्मुंबई यांचेकडे इन्सा हटमेंटस, ई-ब्लॉक, आजाद मैदान, महापालिका मार्ग, मुंबई ४०० ००१ या कार्यालयाचे पत्त्यावर पाठविण्यात याव्यात. उप संचालक, नगररचना, बृहन्मुंबई यांच्याकडे सदरच्या कालावधीत प्राप्त होणाऱ्या हरकती/सूचना यावर उक्त अधिनियमाच्या कलम ३७ च्या पोट-कलम (१कक) अन्वये कार्यवाही करण्यात येईल ;

## परिशिष्ट

Regulation 56(3)(c) and 57(4)(c) is proposed to be replaced as follows :—

Conversion of Industrial Zone to allow the Uses permissible in Residential or Commercial Zone.

With the previous approval of the Commissioner, any open land in the Industrial Zone, (I-Zone) (including industrial estates), excluding lands of cotton textile mills, may be permitted to be converted into Commercial or Residential zone for permissible uses in the Residential Zone (R. Zone) or Commercial Zone (C Zone) subject to payment of premium to be paid equal to 20 per cent of the rate of Developed land as given in the Annual Statement of Rates published by IGR every year. The area for conversion shall be considered after deduction of area under proposed DP Road/Sanctioned Regular line/Existing Municipal Road affecting the plot/s.

Such conversion shall be subject to the following :---

(a) Conversion of Industrial Zone to Residential/Commercial Zone in respect of closed industries shall be permitted subject to NOC from Labour Commissioner, GoM. Provided that where conversion has been permitted on the basis of this certificate, Occupation Certificate will not be given unless a no dues certificate is granted by the Labour Commissioner.

(b) However, in respect of any open land in the Industrial Zone where industry never existed, NOC from Labour Commissioner will not be required.

(c) If the land under such conversion admeasures.

(i) less than 2000 sq.m. either 10 per cent amenity space in the form of open land or 5 per cent built up space in the proposed construction at appropriate location preferably on ground floor shall be handed over to MCGM free of cost. Such areas shall be granted over and above the FSI permissible on the plot.

(ii) Equal to 2000 sq. m or more amenity space area to be handed over to MCGM shall be as detailed below :—

1	2000 Sq. m. or more, but less than 2 Ha.	10	Entire amenity space shall be designated as Public Open Space (PSO).

(d) These areas will be addition to the recreational space as required to be provided under regulation 23.

(e) The required segregating distance as prescribed under these Regulations shall be provided within such land intended to be used for residential or commercial purposes.

(f) Such residential or commercial development shall be allowed within the permissible FSI of the nearby Residential or Commercial Zone.

(g) Such provisions for public utilities, amenities and open space shall be considered to be reseverations in the DP.

(h) Public utility and amenity plots shall not be developed under Accomodation of Reservation policy.

Note.—(i) Necessary segregating distance shall be provided from industiral use.

(ii) In the event of DP having provided a reservation/reservations on a plot desiring conversion from Industrial Zone to Residential/Commercial Zone, the following shall apply :-

(a) If the area under DP reservation to be handed over to MCGM (excluding the areas under DP roads/road setback) is less than the required area of public amenity space as per this Regulation, only the additional land area shall be provided for public amenity spaces.

(b) If the area under DP reservation to be handed over to MCGM, (excluding the areas under DP roads/road setback), is more than the required area of public amenity spaces as per the Regulation, then the provision for public amenity spaces is not necessary.

(c) In case of plot area under conversion is less than 2000 sq.mt. land component either 10 per cent amenity space in the form of open land or 5 per cent built up space shall be considered for the purpose of amenity space as per note(a) and (b) above.

(iii) Out of the floor area as per basis FSI, proposed to be utilized for residential development, 20 per cent of the same shall be built for residential tenements, each having built up area upto 50 sq.m. However, FSI upto 25 per cent of total floor area in residential development may be allowed to be utilized for commercial users.

(iv) If the development is already in progress and if full Occupation Certificate has not been granted to all buildings in the layout, then the land owner/developer may convert the proposal in accordance with the provisions of this Regulation subject to the following conditions :-

(a) The revised provisions will be applicable in totality. The benefit of both old and revised Regulations shall not be allowed.

(b) The benefit of revised Regulations will be applicable only in cases where,—

(i) full Occupation Certificate has not been granted to all buildings in the layout and

(ii) required public amenity space or DP reservation, if any, has been handed over to the Corporation is more than required as per new regulation shall be retained to the Corporation. If it is less than requirement as per new regulation, the requirement can be adjusted as per new regulation, may be considered by the Corporation.

### Notice

MAHARASHTRA REGIONAL AND TOWN PLANNING ACT, 1966.

No. TPB. 4313/630/CR-107/2013/UD-11.—Whereas the Development Control Regulations of Greater Mumbai (hereinafter referred to as “the said Regulations”) have been sanctioned by the Government *vide* Urban Development Department Notification No. DCR. 1090/RDP/UD-11, dated 20th February 1991, under section 31(1) of Maharashtra Regional and Town Planning Act, 1966 (hereinafter referred to as “the said Act”) to come into force with effect from 25th March 1991 ;

And whereas, the Regulations 56(3)(c) and 57(4)(c) of the said regulations deals with conversion of Industrial Zone into Residential/Commercial Zone ;

And whereas, the Municipal Commissioner, Municipal Corporation of Grater Mumbai after considering the order passed by the Hon’ble Bombay High Court in Writ Petition 651/2013 on 13th March 2014 and other Writ Petitions filed on the same line in the Hon’ble High Court, regarding issue related to amenity space in respect of conversion of Industrial Zone to Residential/ Commercial Zone, requested to the State Government to issue suitable directives in respect of modification in provisions of Regulation 56(3)(c) and 57(4)(c) ;

And whereas, the State Government has proposed amendments in the Development Cotrol Regulations of Muncipal Corporation in the State in respect of such conversion of Industrial Zone into Residential/Commercial Zone, in which, Residential/Commercial development in Industrial Zone is to be permitted on payment of premium along with other modification in the Development Control Regulations of Municipal Corporations in the State ;

And whereas, the State Government is of the opinion that the existing provision of Regulation 56(3)(c) and 57(4)(c) of the said Regulations should be modified ;

And whereas, in the public interest it is necessary to urgently carry out suitable modification to the Regulation 56(3)(c) and 57(4)(c) of the said Regulations, as specifically described in the Schedule appended hereto (hereinafter referred to as “the proposed modification”).

Now, therefore, after considering the above facts and circumstances and in exercise of powers vested in it under sub-section (1AA) of section 37 of the said Act, and all other powers enabling it in this behalf, the Government hereby publishes a Notice for inviting suggestions and objections from any person with respect to proposed modifiction, as required by clause(a) of sub-section (1AA) of section 37 of the said Act, within a period of one month from the date of publication of this Notice in the *Maharashtra Government Gazette*.

Any objections/suggestions in respect of the proposed modification may be forwarded before the expiry of one month from the date of publication of this Notice in the *Maharashtra Government Gazette*, to the Deputy Director of Town Planning, Greater Mumbai, having his office at ENSA Hutments, E-Block, Azad Maidan, Mahapalika Marg, Mumbai 400 001. Any objection or suggestion, which may be reseived by the Deputy Director of Town Planning,

Greater Mumbai within the said period shall be dealt with in accordance with the provisions of the said sub-section (1AA) of section 37 of the said Act.

(g) Such provisions for public utilities, amenities and open space shall be considered to be reservations in the DP.

(h) Public utility and amenity plots shall not be developed under Accomodation of Reservation policy.

*Note.*—(1) Necessary segregating distance shall be provided from industiral use.

(2) In the event of DP having provided a reservation/reservations on a plot desiring conversion from Industrial Zone to Residential/Commercial Zone, the following shall apply :—

(a) If the area under DP reservation to be handed over to MCGM (excluding the areas under DP roads/road setback) is less than the requied area of public amenity space as per this Regulation, only the additional land area shall be provided for public amentity spaces.

(b) If the area under DP reservation to be handed over to MCGM, (excluding the areas under DP roads/road setback), is more than the required area of public amenity spaces as per the Regulation, then the provision for public amenity spaces is not necessary.

(c) In case of plot area under conversion is less than 2000 sq.mt. land component either 10 per cent amenity space in the form of open land or 5 per cent built up space shall be considered for the purpose of amenity space as per note (a) and (b) above.

(3) Out of the floor area as per basis FSI, proposed to be utilized for residential development, 20 per cent of the same shall be built for residential tenenments, each having builtup area upto 50 sq.m. However, FSI upto 25 per cent of total floor area in residential development may be allowed to be utilized for commercial users.

(4) If the development is already in progress and if full Occupation Certificate has not been granted to all buildings in the layout, then the land owner/developer may convert the proposal in accordance with the provisions of this Regulation subject to the following conditions :—

(a) The revised provisions will be applicable in totality. The benefit of both old and revised Regulations shall not be allowed.

(b) The benefit of revised Regulations will be applicable only in cases where,—

(i) full Occupation Certificate has not been granted to all buildings in the layout and

(ii) required public amenity space or DP reservation, if any, has been handed over to the Corporation is more than required as per new regulation shall be retained to the Corporation. If it is less than requirement as per new regulation, the requirement can be adjusted as per new regulation, may be considered by the Corporation.

No. TPB. 4316/452/CR-170/2016/UD-11.—Whereas the Maharashtra Industrial Development Corporation is deemed to have been appointed as the Special Planning Authority (hereinafter referred to as “the said Authority”), by virtue of the provisions of sub-section (1A) of Section 40 of the Maharashtra Regional and Town Planning Act, 1966 (hereinafter referred to as “the said Act”) over any area where Chapter VI of the Maharashtra Industrial Development Corporation Act, 1961 applies or any other area comprising Government land transferred to the Maharashtra Industrial Development Corporation (hereinafter referred to as “MIDC”);

And whereas, the said Authority has revised the Development Control Regulations (hereinafter referred to as “the said Revised Regulations”) which have been sanctioned by the Government in the Urban Development Department *vide* Notification No. TPB. 4308/465/CR-64/08/UD-11, dated 31st August 2009 so as to come into force with effect from 24th September 2009;

And whereas, the said Authority in its Board Meeting No. 362, dated 22nd June 2015 *vide* Resolution No. 5503 has decided to incorporate provision of IT and ITES Policy 2015 in the said Revised Regulations and submitted to the Government for its sanction, a modification proposal to the Regulations 18.4.1. of the said Revised Regulations *vide* letter dated 6th April 2016, after completing the legal procedure under Sections 37(1) of the said Act, (hereinafter referred to as “the proposed modification”);

And whereas, after consulting the Director of Town Planning, Maharashtra State, the Government is of the opinion that the proposed modification should be sanctioned with some changes ;

Now, therefore, in exercise of the powers conferred by sub-section (2) of the Section 37 of the said Act, the Government hereby :—

(a) Sanctions the proposed modification with some changes, as described more specifically in the Schedule appended hereto.

(b) Fixes the date of publication of this Notification in the *Official Gazette* as the date of coming into force of this modification.

(c) Directs the Maharashtra Industrial Development Corporation that in the Schedule of Modification sanctioning the said Revised Regulations, after the last entry, the Schedule referred to as (A) above shall be added.

(v) Premium to be received by the MIDC as per provisions in this regulation shall be deposited in a separate fund viz. "Critical Infrastructure Fund for IT/ITES Industries" and this fund shall be utilized only for creation of Critical Infrastructure for IT/ITES Industries ;

Provided that, in the event, the developer come forward for providing such off site infrastructure at his own cost, instead of paying premium as prescribed above, then the MIDC may determine the estimated cost of the work by using rates prescribed in District Schedule of Rates (DSR) of the relevant year, in which order for commencement of such work is issued. The MIDC shall also prescribe the standards for the work. After completion of the works, the MIDC shall verify and satisfy itself that the same is developed as per prescribed standards and thereafter, by deducting the cost of works, the balance amount of premium shall be recovered from such developer before issuing Occupancy Certificate :

Provided that, in case of cost of work is more than the premium to be recovered, such additional cost to be borne by such developer.

(vi) Permission for erecting towers and antenna upto height permitted by the Civil Aviation Department shall be granted by the Chief Executive Officer, MIDC as per the procedure followed for development permission or otherwise as may be decided by the Government.

(vii) While developing site for IT/ITES with additional FSI, support services as defined in the IT Policy 2015, shall be allowed.

(viii) The Directorate of Industries will develop a web portal on which the developer of every IT Park will be bound to provide/update detailed information about names of the units in the park, utilization of built-up area and activities being carried out, manpower employed in the IT Park for IT/ITES and support services on yearly basis.

If a private IT Park has availed additional FSI as per the provisions of IT/ITES policy and subsequently it is found that the built-up space in the park is being used for non IT/ITES/ Commercial Activities/any other activity not permitted as per the IT/ITES policy under which the said park was approved a penal action as below will be taken, the payment will be shared between the MIDC and the Government in the ratio of 3:1.

(a) The misuse shall be ascertained by physical site verification of the said private IT Park by a team of officers from the Directorate of Industries and the MIDC which has approved the building plans of the said private IT Park.

(b) A per day penalty equal to 0.3% of the prevailing ready reckoner value of the built-up area that has been found to be used for non-IT/ITES activities.

(c) The penalty will be recovered from the date of commencement of unauthorized use till the day non IT use continues.

After payment of the penalty to the MIDC which has sanctioned the building plans of the concerned private IT park, the said private IT Park will restore the use of premises to the original purpose for which LOI/Registration was granted. If the private IT Park fails to pay penalty and/or restore the use to its original intended use, the MIDC will take suitable action under the MRTP Act against the erring private IT Park under intimation to the Directorate of Industries. This provision will also be applicable to existing IT Parks.

These provisions will be over and above the penal provisions of the Maharashtra Regional and Town Planning Act, 1966.
