Whereas, the Development Plan of "**P/North**" Ward of Greater Mumbai (hereinafter referred to as "the said Development Plan") has been sanctioned by the Government in the Urban Development Department under section 31(1) of the Maharashtra Regional and Town Planning Act, 1966 (hereinafter referred to as "the said Act") vide Notification No. TPB 4392/6176/ UD-11 dated 15<sup>th</sup> April 1993, so as to come into force with effect from the 1<sup>st</sup> June 1993;

And whereas, the Mumbai Metropolitan Region Development Authority (hereinafter referred to as "the said Authority) is implementing Mumbai Metro Master Plan:

And whereas, the said Authority has requested that the land admeasuring about 19.59 Hectare, bearing CTS No.6A(pt.)village Malvani (hereinafter referred to as "the said land"), which is reserved for Recreation Grounds, Government Staff Quarters, Government Offices, Court & Court Housing, Educational Complex, Indian Institute of Geomagnetism, School for Mentally Retarded, Blindmen Association Housing, Integrated Health Care and Health Training Centre, Parking Lot & Development Plan Roads in the said Development Plan, is required for Car Depot for Metro line-II and also requested to reserve the said land for **Metro Car Depot, allied users and Commercial** in the said Development Plan;

And whereas, the Government finds it expedient to delete reservations on the said land and to reserve it for reservation of **Metro Car Depot, allied users** and Commercial;

And whereas, the Government in exercise of the powers conferred under sub-section (1AA) of Section 37, had issued Notice dated the 20th June 2015 for inviting suggestions/objections from general public with regard to reserving the said land for the purpose of **Metro Car Depot, allied users and Commercial** (hereinafter referred to as "the proposed modification) and appointed the Deputy Director of Town Planning, Greater Mumbai as the officer (hereinafter referred to as "the said Officer") to submit a report on the suggestions/objections received in respect of the proposed modification to the Govt. after giving hearing to the concerned persons and the Municipal Corporation of Greater Mumbai;

And whereas, the Notice dated the 20<sup>th</sup> June 2015 was published in Maharashtra Government Gazette, Extra-ordinary Konkan Divisional Supplement, dated the 20<sup>th</sup> June 2015 (hereinafter referred to as "the Official Gazette")and the said Officer has submitted his Report vide letter No. 1073 dt. 5<sup>th</sup> December 2015, through the Director of Town Planning, Maharashtra State, after completing the legal formalities stipulated under Section 37(1AA) of the said Act;

And whereas, after considering the Report of the said Officer, the suggestions/objections received from the general public and after consulting the Director of Town Planning, Maharashtra State, the Government is of the opinion that the proposed modification is required to be sanctioned with some changes.

Now therefore, in exercise of the powers conferred upon it under section 37(1AA)(c) of the said Act, the Government hereby:-

(A)Sanctions the said modification proposal as follows:--

"The land admeasuring about 16.40 Hectare, bearing CTS No.6A(pt.), village Malvani is deleted from reservations of Recreation Grounds, Government Staff Quarters, Government Offices, Educational Complex(part), Indian Institute of Geomagnetism, School for Mentally Retarded, Blindmen Association Housing, Integrated Health Care and Health Training Centre, Parking Lot & Development Plan Roads and reserved for Metro Car Depot, allied users and Commercial (as more particularly shown on the part plan attached herewith). The Appropriate Authority for development of the said reservation shall be Mumbai Metropolitan Region Development Authority"

- (B) Fixes the date of publication of this Notification in the Official Gazette, as the date on which the said modification shall come into force;
- (C) Directs the Municipal Corporation of Greater Mumbai that, in the Schedule of Modifications appended to the Notification sanctioning the said Development Plan, after the last entry a new entry as per (A) above shall be added.

A plan showing the sanctioned modification shall be kept open for the inspection by the general public during the office hours on all working days at following places:-
