In reference to above, in regard to process NOC cases expeditiously a meeting was held with Assistant Engineer/PD, MCGM on 20.2.17 in the chamber of undersigned and various aspects of issue of NOC was discussed. Further, a meeting was held with Chief Engineer (PD), MCGM in his chamber jointly with CE (G), Central Railway on 07.03.17 and detailed discussion was held in this regard. The copy of the minutes was sent vide this office letter dated 10.03.2017. It was decided that the issues of NOC will be done in two phases. As decided, actions taken are furnished as below.

Phase-I:

- a.) Sr. DEN/Estate south/BCT has been nominated as nodal officer to co-ordinate the matters with MCGM and his details i.e. Name, mobile no. and e-mail id and was sent to MCGM on 10.3.17.
 - b) To provide online linkage to the officers of Railways. Details of the officers, i.e. name, mobile no., e-mail id and divisional area covered for issue of NOC were also sent on 10.03.17 to provide id and password by MCGM for access to their system.
 - Necessary documents/guidelines including payments/parameters etc. to be considered for issue of NOC on single window basis at MCGM has been sent to MCGM for incorporating in their system. MCGM will make necessary changes in their software and provide user-id and password to concerned Railway officers.
 - Shri V.P. Chithore, Chief Engineer (PD), MCGM has been personally requested over phone and also vide this office letter of even No. dt.07.04.17 to provide id and password to the concerned Railway officers. He has assured that id and password of the linkage will be provided to Railways by 17.04.17.
- To mark the buffer zone on GIS of MCGM, the staff will be deputed when GIS section of MCGM will be ready and ask Railway to depute the staff. CE/PD,MCGM has been personally requested to advise GIS section to expedite.
- **B. Phase-II:** For Online approval system, software will be developed and will be integrated with online NOC approval system of MCGM.
