Exemption Order in Development Charge under sub-section (2) of Section 124F for the proposal of warehouse /godowns within the area of Municipal Corporation of Greater Mumbai.

NOTIFICATION

Whereas, the State Government in Urban Development Department has amended Section 124F of the Maharashtra Regional and Town Planning Act, 1966 as the Maharashtra Regional and Town Planning (Amendment) Ordinance, 2015 (Maharashtra ordinance VI of 2015). (hereinafter referred to as "the said Act");

And whereas, amended sub-section (2) of Section 124F of the said Act empowers State Government to partially exempt the payment of development charge payable on the development of any land or building which is proposed for warehouse or godown;

And whereas, the State Government in Urban Development Department partially exempted the development charge payable on the development of any land or building proposed for Warehouse or Godown in the area of Municipal Corporation of Greater Mumbai to the extent of 90%;

And whereas, the Municipal Commissioner, Municipal Corporation of Greater Mumbai has requested to grant exemption to the extent of 95% instead of earlier 90% in the development charges and development cess to be recovered, while granting permission for warehouse or godown due to provision of Development cess equivalent to Development charges incorporated in DCPR-2034 which enhance cost of construction permit;

And whereas, Government in Urban Development Department is of the opinion that the request of Municipal Corporation of Greater Mumbai is in tune with Ease of Doing Business and need to be sanctioned;

Now therefore, in exercise of its power under sub-section (2) of amended Section 124F of the said Act, the Government of Maharashtra in supersession of earlier Notification dated 13th May, 2015 hereby partially exempts the payment of development charge payable on the development of any land or building proposed for warehouse or godown, in the area of Municipal Corporation of Greater Mumbai to the extent in the schedule appended below;



SCHEDULE

Sr. No.	<u>Particulars</u>	Extent of Exemption
1)	Development of land for warehouse or godown use, also involving any building or construction operations.	95%

The Municipal Corporation of Greater Mumbai within its jurisdiction shall be entitled to pass an order to exempt the payment of development charges payable on the development of any land or building which is proposed for warehouse or godown to the extent indicated above.

The above notification shall have effect on the date of appearing this notification in the Maharashtra Government Gazette.
