Modifications in the Point at Sr.No.5A of the Minutes of Meeting held on 08.11.2017 under the Chairmanship of Hon.M.C. with PEATA, MCHI and NAREDCO

Traffic/ simulation survey shall not be insisted	For prescribing the R.L. to the existing road of width less than 9 m to 9 m, traffic/ stimulation survey is conducted by the Dy.Ch.E.(Traffic)	Hon.M.C. stated that as per the provision of Clause 5.4.1(I), the U.D.D. directed the MCGM to convert all roads of width less than 9 m to 9 m and above as per the site conditions through M.R.& T.P. Act or M.M.C. Act provisions. Hence, traffic survey shall not be insisted for prescribing the R.L. to convert the road of prescribing the R.L. to convert the road of width less than 9 m to 9 m. Ch.E.(Rds)/ Dy.Ch.E.(Tr) to take the cognizance of same and process such proposals of prescribing R.L. of below 9 mt. Roads to 9 mt. Roads without insisting traffic simulation study.	Reference is requested to guidelines issued u/No.ChE/612 0/DP/Gen dt.3.6.2015 for prescription of R.L. to various roads as per the State Govt.'s orders for conversion of all roads of width less than 9 m to 9 m and above. As per the Sr.No.III (a)"R.L. upto 9 m width shall be dealt by Zonal Building Proposal Deptt. as per the prevailing practice".	Prescribing R.L. upto 9.15 meter width u/s 297 of MMC Act 1888 shall be dealt by Zonal Building Proposal Department. as per the prevailing practice" without insisting Traffic/ simulation survey and Traffic count study. However, prescribing R.L. above 9.15 meter width u/ 297 of MMC Act 1888 and New public street/ New R.L. u/s 291 read with 294 of MMC Act 1888 shall be dealt by Dy.Ch.E.(Traffic) Department. Traffic stimulation study and Traffic count study from Traffic consultant (having qualification of Post Graduate degree in Transportation planning and at least having five years experience of handling the works in the field of transportation and planning) is mandatory for prescribing of any R.L. above 9.15 meter width.
