## NOTE ON INTERIM ORDER

- The instant dispute is in relation to MSW (Municipal Solid Wastes) being dumped at Deonar and/or Mulund dumping grounds in the city of Mumbai.
- The MSW (Management and Handling Rules), 2000 have now been superseded by Solid Waste Management Rules, 2016.
- As regards C&D Waste (Construction & Demolition Waste), the same are governed by independent set of rules i.e. Construction and Demolition Waste Management Rules, 2016.
- Respondent No.1 Corporation has from time to time being issuing IOD (Intimation of Disapproval) with a specific condition that a debris management plan is to be submitted to the Solid Waste Management Department of Respondent No.1 Corporation (see page 137 @ 146).
- 5. The Waste / Debris Management Plan approved by the Solid Waste Management Department of Respondent No.1 Corporation inter alia mandates that the demolition / construction debris shall be transported to various unloading / land filing sites, which are outside the municipal limit of the city of Mumbai (eg:- Sector-25, 25A of Vahal, Ulwe Node, Navi Mumbai and CTS No. Survey No. 153 to 160 village of Mouje Sasunavghar, Mumbai Ahmedabad Highway, Taluka Vasai, District Thane).
- The Impugned Orders confuse the two concepts of i.e. MSW and C&D Waste and assumes MSW to be inclusive of C&D Waste.
- 7. In view of the above, considering that the development in entire suburban region of Mumbai is at a standstill and the High Court has attempted to takeover the statutory powers to be discharged by Respondent No.1 Corporation since 01.03.2016, the following workable solution is proposed:-

Pending the hearing and disposal of the Petition, Respondent No.1 / Corporation / State Government is permitted to grant permission / 10D after taking an undertaking from all the respective applicants to the effect that:-

- a. the construction and demolition waste is disposed off as per the Waste Management Plan at the land filling sites [eg:- Sector-25, 25A of Vahal, Ulwe Node, Navi Mumbai and CTS No. Survey No. 153 to 160 village of Mouje Sasunavghar, Mumbai – Ahmedabad Highway, Taluka Vasai, District Thane]; and
- b. in case of any wet solid waste, the same shall be disposed off on the construction site itself and in case of any dry solid waste, the same shall be disposed off in a manner that the same is not dumped at Deonar and/or Mulund Dumping grounds.
